

# Community Standards, Terms and Conditions and Privacy Policy

## Community Standards

As we create a community of HouseSitMexico's members, we seek to bring together honest and reliable people who come from many walks of life. Some are homeowners or renters of homes in Mexico. Others are interested in house sitting in Mexico. We believe a foundation of trust grounded in consistent expectations of host (homeowner or renter) and guest (house sitter/s) behavior is required. We've established these Community Standards (as part of our Terms and Conditions) to help guide behavior and codify the values that are at the core of our mutual-help community.

The following *Community Standards* build upon these rules and may be refined over time.

### Truthfulness and Authenticity

Homeowners/renters (hosts) must not misrepresent either written or photographic information in their listings regarding pets, the home, location, responsibilities or any aspect of the house sitting assignment. Sitters (guests) must not misrepresent any information (written or photographic) they have shared either in their Profile or through any other means. This includes references, their age, location, knowledge or other experience. No persons or pets other than those specifically discussed and agreed to are permitted to live at the premises during the term of the house sitting assignment.

### Reliable Fulfillment of Agreement

We ask all members to faithfully fulfill and respect all the terms, requirements, and definitions of the housesitting assignment as entered into by both homeowner/renter (host) and the house sitter/s (guests). We strongly advise that every house sitting agreement have its terms memorialized in writing, however verbal agreements must be respected as well as those that are written.

### Safety and Security

HouseSitMexico homeowner/renter members share their homes, furnishings, and often pets with the house sitter they select. We ask all members to respect others' property, information, and personal belongings. All members must refrain from endangering or threatening anyone, or harming any thing. Homeowners/renters should not keep unsecured weapons, disease risks, or dangerous animals in your listing. House sitters may not bring any of these to the listing.

### Bad Behavior On Any Member's Part

Your membership at HouseSitMexico requires that you not take property that doesn't belong to you, use someone's property without their permission, create a disturbance to fellow members or their neighbors, copy others' keys or identity documents, damage others' property, remain in listings after a stay is concluded, or threaten anyone with bad ratings or any other penalty or harm to obtain compensation or other benefits.

We also take rudeness by members of HouseSitMexico very seriously (whether to a fellow member or any other person).

Determination as to whether a HouseSitMexico member has failed to meet any of these Community Standards is entirely at the discretion of HouseSitMexico management, and may result in the (uncompensated) loss of membership, as well as being blocked from future re-joining.

## Terms and Conditions of Use

### 1. Introduction

- 1.1 These terms and conditions shall govern your use of our website.
- 1.2 By using our website, you accept these terms and conditions in full; accordingly, if you disagree with these terms and conditions or any part of these terms and conditions, you must not use our website.
- 1.3 If you register with our website, submit any material to our website or use any of our website services, we will ask you to expressly agree to these terms and conditions.
- 1.4 You must be at least 21 years of age to use our website; and by using our website and by agreeing to these terms and conditions, you warrant and represent to us that you are at least 21 years of age.
- 1.5 Our website uses cookies; by using our website or agreeing to these terms and conditions, you consent to our use of cookies in accordance with the terms of our Privacy and Cookies Policy.
- 1.6 The term, "homeowner" as used on the website refers to the member whose home is to be the site of the house sitting assignment.
- 1.7 Homeowner/members using the HouseSitMexico.com website must either be the owner of the site of a house sitting assignments, or they must have permission of the owner (as renters may have).

### 2. Copyright notice

- 2.1 Copyright (c) 2018 HouseSitMexico
- 2.2 Subject to the express provisions of these terms and conditions:
  - (a) we, together with our licensors, own and control all the copyright and other intellectual property rights in our website and the material on our website; and
  - (b) all the copyright and other intellectual property rights in our website and the material on our website are reserved.

### 3. License to use website

- 3.1 You may:
  - (a) view pages from our website in a web browser;
  - (b) download pages from our website for caching in a web browser;
  - (c) print pages from our website;

- (d) stream audio and video files from our website; and
  - (e) use our website services by means of a web browser,
- subject to the other provisions of these terms and conditions.

- 3.2 You may only use our website for your own personal purposes, and you must not use our website for other people (beyond you, your spouse and family, and/or partner) or for any other purposes.
- 3.3 Except as expressly permitted by these terms and conditions, you must not edit or otherwise modify any material on our website.
- 3.4 Unless you own or control the relevant rights in the material, you must not:
- (a) republish material from our website (including republication on another website);
  - (b) sell, rent or sub-license material from our website;
  - (c) show any material from our website in public;
  - (d) exploit material from our website for a commercial purpose; or
  - (e) redistribute material from our website.
- 3.5 Notwithstanding Section 3.4, you may redistribute our newsletters and updates of available house sits sent to you.
- 3.7 We reserve the right to restrict access to areas of our website, or indeed our whole website, at our discretion; you must not circumvent or bypass, or attempt to circumvent or bypass, any access restriction measures on our website.

#### **4. Acceptable use**

- 4.1 You must NOT:
- (a) use our website in any way or take any action that causes, or may cause, damage to the website or impairment of the performance, availability or accessibility of the website;
  - (b) use our website in any way that is unlawful, illegal, fraudulent or harmful, or in connection with any unlawful, illegal, fraudulent or harmful purpose or activity;
  - (c) use our website to copy, store, host, transmit, send, use, publish or distribute any material which consists of (or is linked to) any spyware, computer virus, Trojan horse, worm, keystroke logger, rootkit or other malicious computer software;
  - (d) conduct any systematic or automated data collection activities (including without limitation scraping, data mining, data extraction and data harvesting) on or in relation to our website without our express written consent;
  - (e) access or otherwise interact with our website using any robot, spider or other automated means;
  - (f) violate the directives set out in the robots.txt file for our website; or
  - (g) use data collected from our website for any direct marketing activity (including without limitation email marketing, SMS marketing, telemarketing and direct mailing).
- 4.2 You must ensure that all the information you supply to us through our website, or in relation to our website, is true, accurate, current, complete and non-misleading.

## **5. Registration and accounts**

- 5.1 To be eligible for an individual account on our website under this Section 5, you must be at least 21 years of age.
- 5.2 You may register for an account with our website by completing and submitting the account registration form on our website, and clicking on the verification link in the email that the website will send to you.
- 5.3 You must not allow any other person (other than a partner or member of your household) to use your account to access the website, nor may you share privileged information you acquire as a member of HouseSitMexico (such as details relating to a house sitting assignment). Referring non-members to HouseSitMexico's house sitting opportunities can be cause for loss of membership, at the discretion of HouseSitMexico.
- 5.4 You must notify us in writing immediately if you become aware of any unauthorised use of your account.

## **6. User login details**

- 6.1 If you register for an account with our website, you will be asked to choose a password, which you must keep confidential.
- 6.2 You must not use your account in connection with the impersonation of any person.
- 6.3 You must notify us in writing immediately if you become aware of any disclosure of your password.
- 6.4 You are responsible for any activity on our website arising out of any failure to keep your password confidential, and may be held liable for any losses arising out of such a failure.

## **7. Cancellation and suspension of account**

- 7.1 You may cancel your membership (account) by sending an email to [admin@housesitmexico.com](mailto:admin@housesitmexico.com), informing us of your decision. You will not be entitled to any refund if you choose to cancel your account.

## **8. House Sitter and Homeowner Services**

- 8.1 To become a subscriber to our website services, you must pay the applicable membership fees for the type and duration of membership selected during the account registration procedure. We will send you an acknowledgement of your order. The contract between us for the supply of the website services shall come into force upon the issue of the order acknowledgement.
- 8.2 Registered users with active membership will be able to access house sitting related services on our website, which depending on whether the member is a homeowner and/or a house sitter may include:
  - (a) the publication of a personal Profile on our website (for house sitters);
  - (b) the publication of house sitting Assignments (for homeowners and/or renters);
  - (c) access to our searchable database of available house sits;
  - (d) private messaging to and from other website users
  - (e) posting to the website's Members' Blog

- 8.3 We may from time to time vary the benefits of membership. If in our reasonable opinion such a variation results in a substantial loss of value or functionality, you shall have the right to cancel your membership, and we will refund to you any amounts paid to us in respect of any period of membership after the date of such cancellation.
- 8.4 At the end of any period of membership for which you have paid, and subject to the other provisions of these terms and conditions, your membership will be automatically cancelled, unless you renew the membership and pay the applicable fees.
- 8.5 Save where expressly requested or permitted by us to do so, you must not add any information to our website that may facilitate direct communications with other users (including without limitation email addresses, postal addresses, instant messaging IDs, telephone numbers, fax numbers, personal website URLs and social networking profile URLs).
- 8.7 You acknowledge that we cannot be held responsible for the behavior of our users, either on or off the website, and we cannot guarantee that any information provided by a user is true, accurate, complete, current and not misleading; and will not hold us liable in respect of any loss or damage arising out of any user behavior or user information.
- 8.8 Any HouseSitMexico member (either homeowner and/or house sitter) known to have broken a firm house sitting agreement without good cause will lose the remaining portion of their membership in HouseSitMexico without a refund.
- 8.9 Failure to comply with these Terms and Conditions is adequate reason for those members to lose the remaining portion of their membership in HouseSitMexico without a refund.

## **9. Personal profiles**

- 9.1 All information that you supply on or to the website (including video, photos, text or other media), including all that which may be part of a house sitter Profile or Listing of a house sitting assignment, must be true, accurate, current, complete and non-misleading.
- 9.2 House sitters must create a House Sitter Profile (with photograph) on our website, and keep it up to date.
- 9.3 Personal profile information must also comply with the provisions of Section 4 and Section 13.
- 9.4 House sitters will not charge for their services.

## **10. Money back guarantee**

- 11.1 You may request a refund of the full amount you paid for your membership if you have utilized the website's features to seek a house sitter in good faith (both listing the house sit and searching the online house sitter database), and have not succeeded in finding a house sitter during the term of your membership.
- 11.2 Members who wish to house sit and are unsuccessful in being selected as house sitters do not qualify for a money back guarantee.
- 11.3 We will refund money using the same method used to make the payment.

## **12. Your content: license**

- 12.1 In these terms and conditions, "your content" means all works and materials (including without limitation text, graphics, photographs, audio material, video material, and files) that you submit to us or our website for storage or publication on, processing by, or transmission via, our website.
- 12.2 You grant to us a worldwide, irrevocable, non-exclusive, royalty-free license to use, reproduce, store, adapt, publish, translate and distribute your content in any existing or future media.
- 12.3 You grant to us the right to sub-license the rights licensed under Section 12.2.
- 12.4 You grant to us the right to bring an action for infringement of the rights licensed under Section 12.2.
- 12.6 You may edit your content to the extent permitted using the editing functionality made available on our website.
- 12.7 Without prejudice to our other rights under these terms and conditions, if you breach any provision of these terms and conditions in any way, or if we reasonably suspect that you have breached these terms and conditions in any way, we may delete, unpublish or edit any or all of your content and is sufficient cause for such members to lose the remaining portion of their membership in HouseSitMexico without a refund.

### **13. Your content: rules**

- 13.1 You warrant and represent that your content will comply with these terms and conditions.
- 13.2 Your content must not be illegal or unlawful, must not infringe any person's legal rights, and must not be capable of giving rise to legal action against any person (in each case in any jurisdiction and under any applicable law).
- 13.3 Your content, and the use of your content by us in accordance with these terms and conditions, must not:
- (a) be libellous or maliciously false;
  - (b) be obscene or indecent;
  - (c) infringe any copyright, moral right, database right, trademark right, design right, right in passing off, or other intellectual property right;
  - (d) infringe any right of confidence, right of privacy or right under data protection legislation;
  - (e) constitute negligent advice or contain any negligent statement;
  - (f) constitute an incitement to commit a crime, instructions for the commission of a crime or the promotion of criminal activity;
  - (g) be in contempt of any court, or in breach of any court order;
  - (h) be in breach of racial or religious hatred or discrimination legislation;
  - (i) be in breach of official secrets legislation;
  - (j) be in breach of any contractual obligation owed to any person;
  - (k) depict violence in an explicit, graphic or gratuitous manner;
  - (l) be pornographic, lewd, suggestive or sexually explicit;
  - (m) be untrue, false, inaccurate or misleading;
  - (n) consist of or contain any instructions, advice or other information which may be acted upon and could, if acted upon, cause illness, injury or death, or any other loss or damage;

- (o) constitute spam;
  - (p) be offensive, deceptive, fraudulent, threatening, abusive, harassing, anti-social, menacing, hateful, discriminatory or inflammatory; or
  - (q) cause annoyance, inconvenience or needless anxiety to any person.
- 13.4 Your content must be appropriate, civil and tasteful, in accordance with generally accepted standards of etiquette and behavior on the Internet.
- 13.5 You must not use our website to link to any website or web page consisting of or containing material that would, were it posted on our website, breach the provisions of these terms and conditions.
- 13.6 You must not submit to our website any material that is or has ever been the subject of any threatened or actual legal proceedings or other similar complaint.

#### **14. Data mining**

- 14.1 You must not conduct any systematic or automated data collection activities (including without limitation scraping, data mining, data extraction and data harvesting) on or in relation to our Website without our express written consent.

#### **15. Graphic material**

- 15.1 Your content must not depict violence in an explicit, graphic or gratuitous manner.
- 15.2 Your content must not be pornographic or sexually explicit, or consist of or include explicit, graphic or gratuitous material of a sexual nature.

#### **16. Harmful software**

- 16.1 You must not use the Website to promote or distribute any viruses, Trojans, worms, root kits, spyware, adware or other harmful software, programs, routines, applications or technologies.
- 16.2 You must not use the Website to promote or distribute any software, programs, routines, applications or technologies that will or may negatively affect the performance of a computer or introduce significant security risks to a computer.

#### **17. Factual accuracy**

- 17.1 Your content must not be untrue, false, inaccurate or misleading.
- 17.2 Statements of fact contained in your content must be true; and statements of opinion contained in your content must be truly held and, where possible, based upon facts that are true.

#### **18. Negligent advice**

- 18.1 Content must not consist of or contain any instructions, advice or other information that may be acted upon and could, if acted upon, cause:
- (a) illness, injury or death; or
  - (b) any other loss or damage.

**19. Marketing and spam**

- 19.1 You must not, without our prior written permission, use our Website for any purposes related to marketing, advertising, promotion, or the supply and/or sale of goods and/or services beyond house and/or pet sitting or offering a house and/or pet sitting assignment
- 19.2 Your content must not constitute spam.
- 19.3 You must not use our Website to transmit or send unsolicited commercial communications.
- 19.4 You must not send any spam or marketing communications to any email addresses obtained from our Website.
- 19.5 You must not use our Website to market, distribute or post chain letters, Ponzi schemes, pyramid schemes, matrix programs, "get rich quick" schemes or similar schemes, programs or materials.

**20. Gambling**

- 20.1 You must not use our Website for any purpose related to gambling, gaming, betting, lotteries, sweepstakes, prize competitions or any gambling-related activity.

**21. Professional advice**

- 21.1 You must not use our Website to provide any legal, financial, investment, taxation, accountancy, medical or other professional advice or advisory services.

**22. Netiquette**

- 22.1 Content must be appropriate, civil, tasteful and in accord with generally accepted standards of etiquette and behavior on the Internet.
- 22.2 Content must not be grossly offensive, deceptive, threatening, abusive, harassing, menacing, hateful, discriminatory or inflammatory.
- 22.3 Content should not cause annoyance, inconvenience or needless anxiety.
- 22.4 Do not flame or conduct flame wars on our Website ("flaming" being the sending of hostile messages intended to insult, in particular where the message is directed at a particular person or group of people).
- 22.5 Do not troll on our Website ("trolling" being the practice of deliberately upsetting or offending other users).
- 22.6 Do not flood our Website with Content focusing upon one particular subject or subject area, whether alone or in coordination with other users.
- 22.7 Your content must not duplicate existing Content on our Website.
- 22.8 You must submit your content to the appropriate part of the Website.
- 22.9 Do not unnecessarily submit textual content in CAPITAL LETTERS.
- 22.10 You should use appropriate and informative titles for all Content.
- 22.11 You must at all times be courteous and polite to other Website users.

**23. Hyperlinks**

23.1 You must not link to any website or web page containing material that would, were it posted on the Website, breach the preceding terms of this Policy.

**24. Breaches of this Policy**

24.1 We reserve the right to edit or remove any Content in our sole discretion for any reason, without notice or explanation.

24.2 Without prejudice to this general right, if you breach this Policy in any way, or if we reasonably suspect that you have breached this Policy in any way, we may:

- (a) delete or edit any of your Content;
- (b) send you one or more formal warnings;
- (c) temporarily suspend your access to a part or all of the Website;
- (d) permanently prohibit you from using a part or all of the Website;
- (e) block computers using your Internet Protocol address from accessing the Website;
- (f) contact your internet services provider and request that they block your access to the Website; and/or
- (g) bring court proceedings against you for breach of contract or otherwise.

**25. Banned users**

25.1 Where we suspend or prohibit your access to the Website or a part of the Website, you must not take any action to circumvent such suspension or prohibition (including without limitation using a different account).

**26. Monitoring**

26.1 Notwithstanding the provisions of this Policy, we do not actively monitor Content.

26.2 If you become aware of any material on the Website that contravenes this Policy, please notify us by sending an email to [admin@housesitmexico.com](mailto:admin@housesitmexico.com).

**27. Report abuse**

27.1 If you learn of any unlawful material or activity on our website, or any material or activity that breaches these terms and conditions, please let us know.

27.2 You can let us know about any such material or activity via email to [admin@housesitmexico.com](mailto:admin@housesitmexico.com).

**28. Limited warranties**

28.1 We do not warrant or represent:

- (a) the completeness or accuracy of the information published on our website;

- (b) that the material on the website is up to date; or
- (c) that the website or any service on the website will remain available.

28.2 We reserve the right to discontinue or alter any or all of our website services, and to stop publishing our website, at any time in our sole discretion without notice or explanation; and save to the extent expressly provided otherwise in these terms and conditions, you will not be entitled to any compensation or other payment upon the discontinuance or alteration of any website services, or if we stop publishing the website.

## 29. Limitations and exclusions of liability

29.1 Nothing in these terms and conditions will:

- (a) limit or exclude any liability for fraud or fraudulent misrepresentation;
- (b) limit any liabilities in any way that is not permitted under applicable law; or
- (c) exclude any liabilities that may not be excluded under applicable law,
- (d) and your statutory rights will not be excluded or limited by these terms and conditions, except to the extent permitted by law.

29.2 The limitations and exclusions of liability set out in this Section 16 and elsewhere in these terms and conditions:

- (a) are subject to Section 16.1; and
- (b) govern all liabilities arising under these terms and conditions or relating to the subject matter of these terms and conditions, including liabilities arising in contract, in tort (including negligence) and for breach of statutory duty, except to the extent expressly provided otherwise in these terms and conditions.

29.3 To the extent that our website and the information and services on our website are provided free of charge, we will not be liable for any loss or damage of any nature.

29.4 We will not be liable to you in respect of any losses arising out of any event or events beyond our reasonable control.

## 30. Indemnity

30.1 You hereby indemnify us, and undertake to keep us indemnified, against any and all losses, damages, costs, liabilities and expenses (including without limitation legal expenses and any amounts paid by us to a third party in settlement of a claim or dispute) incurred or suffered by us and arising directly or indirectly out of:

- (a) any breach by you of any provision of these terms and conditions; or
- (b) your use of our website.

## 31. Breaches of these terms and conditions

31.1 Without prejudice to our other rights under these terms and conditions, if you breach these terms and conditions in any way, or if we reasonably suspect that you have breached these terms and conditions in any way, we may:

- (a) send you one or more formal warnings;

- (b) temporarily suspend your access to our website;
- (c) permanently prohibit you from accessing our website;
- (d) block computers using your IP address from accessing our website;
- (e) contact any or all of your internet service providers and request that they block your access to our website;
- (f) commence legal action against you, whether for breach of contract or otherwise; and/or
- (g) suspend or delete your account on our website.

31.2 Where we suspend or prohibit or block your access to our website or a part of our website, you must not take any action to circumvent such suspension or prohibition or blocking (including without limitation creating and/or using a different account).

### **32. Third party websites**

32.1 Our website includes hyperlinks to other websites owned and operated by third parties; such hyperlinks are not recommendations.

32.2 We have no control over third party websites and their contents, and subject to Section 16.1 we accept no responsibility for them or for any loss or damage that may arise from your use of them.

### **33. Trade marks**

33.1 HouseSitMexico™, our logos and our other registered and unregistered trademarks are trademarks belonging to us; we give no permission for the use of these trademarks, and such use may constitute an infringement of our rights.

33.2 The third party registered and unregistered trademarks or service marks on our website are the property of their respective owners and, unless stated otherwise in these terms and conditions, we do not endorse and are not affiliated with any of the holders of any such rights and as such we cannot grant any licence to exercise such rights.

### **34. Variation**

34.1 We may revise these terms and conditions from time to time.

34.2 We will give you written notice of any revision of these terms and conditions, and the revised terms and conditions will apply to the use of our website from the date that we give you such notice; if you do not agree to the revised terms and conditions, you must stop using our website.

### **35. Assignment**

35.1 You hereby agree that we may assign, transfer, sub-contract or otherwise deal with our rights and/or obligations under these terms and conditions.

35.2 You may not without our prior written consent assign, transfer, sub-contract or otherwise deal with any of your rights and/or obligations under these terms and conditions.

### **36. Severability**

- 36.1 If a provision of these terms and conditions is determined by any court or other competent authority to be unlawful and/or unenforceable, the other provisions will continue in effect.
- 36.2 If any unlawful and/or unenforceable provision of these terms and conditions would be lawful or enforceable if part of it were deleted, that part will be deemed to be deleted, and the rest of the provision will continue in effect.
- 37. Third party rights**
- 37.1 A contract under these terms and conditions is for our benefit and your benefit, and is not intended to benefit or be enforceable by any third party.
- 37.2 The exercise of the parties' rights under a contract under these terms and conditions is not subject to the consent of any third party.
- 38. Entire agreement**
- 38.1 Subject to Section 28.1, these terms and conditions, together with our Privacy Policy, shall constitute the entire agreement between you and us in relation to your use of our website and shall supersede all previous agreements between you and us in relation to your use of our website.
- 39. Law and jurisdiction**
- 39.1 These terms and conditions shall be governed by and construed in accordance with the laws of the United States of America.
- 39.2 Any disputes relating to these terms and conditions shall be subject to the laws of the United States of America.
- 40. Statutory and regulatory disclosures**
- 40.1 We will not file a copy of these terms and conditions specifically in relation to each user or customer and, if we update these terms and conditions, the version to which you originally agreed will no longer be available on our website. We recommend that you consider saving a copy of these terms and conditions for future reference.
- 40.2 These terms and conditions are available in the English language only.

## **Privacy Policy:**

Your privacy is critically important to us. At HouseSitMexico we have a few fundamental principles:

- We don't ask you for personal information unless we truly need it. (We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of our services.

It is HouseSitMexico's policy to respect your privacy regarding any information we may collect while operating our website.

### **Website Visitors**

Like most website operators, HouseSitMexico collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. HouseSitMexico's purpose in collecting non-personally identifying information is to better understand how HouseSitMexico's visitors use its website. From time to time, HouseSitMexico may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

HouseSitMexico also collects potentially personally identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on WordPress.com blogs. HouseSitMexico only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that blog commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog where the comment was left.

### **Gathering of Personally-Identifying Information**

Certain visitors to HouseSitMexico's websites choose to interact with HouseSitMexico in ways that require HouseSitMexico to gather personally identifying information. The amount and type of information that HouseSitMexico gathers depends on the nature of the interaction. For example, we ask visitors who sign up for email contact (e.g.: House Sitter Updates) for their name and email address. Those who purchase a membership are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, HouseSitMexico collects such information only insofar as is necessary or appropriate to fulfill the purpose of the Member's interaction with HouseSitMexico.
